Thank You so much for choosing one of our puppies to become your newest best friend. We know this is a huge decision and want to help you through this in any way we can.

First a little bit about our puppies so you can feel confident in this new adventure...

Our dogs are part of the family, they are raised in our home (not a kennel) and have fantastic lives. We live on 5 acres in southern Indiana near a state forest and our little four-legged kiddos get to hike, swim, run and play. We do most things with our dogs and they get to socialize / interact with many small children and other animals like cats and our other doggies. They are loved and spoiled by their humans daily. The Dam and Sire are both purebreds from long lines of purebreds and reputable breeders. We have tracked 4 generations of AKC purebred bloodlines for both of them.

We prefer to feed and maintain the health of the doggies and puppies with Diamond Naturals Puppy food (we will send home a sample bag) and we stay on top of their health with products from Revival Animal Health and their Vet. The puppies will also be microchipped so they can be returned home if they ever get separated from you.

For the puppies - What can we say but "Puppies are Awesome". We love on and play with them several times a day. We also try to have them grass and potty pad acquainted by the time they are ready to go to their new Furever home. We will also send home the AKC registration packet, the Sire and Dam's AKC Lineage, and a goodie basket with Food for a few days, a blanket with mommies' scent for comfort, and a toy. They will also be up to date on all of their shots.

Due to COVID / Long Distances we are currently using Video Calls to facilitate early viewing of the puppies and will be happy to send pictures as they grow. Also our website will have pictures as they grow up and a way to connect to current and previous litter mates (and their humans). After 6 weeks we can have special arrangements for in-person puppy interaction depending on Social Distancing requirements of that time.

## TERMS AND CONDITIONS

#### **Deposit, Payment of Purchase Price, Fees**

**UPON PAYMENT** of the Initial Deposit & remainder of Purchase Price by Buyer to Seller (the "Purchase Price"), receipt of which is hereby acknowledged, Seller grants, sells, conveys and transfers ownership of the following dog or puppy (the "Dog") to Buyer:

#### Purchase Price is identified as:

Companion Dog (AKC Limited) - \$2,800.00 dollars (\$400 Deposit and \$2,400 at / before delivery)

Full AKC Registration Dog - \$3,800.00 dollars (\$1,000 Deposit and \$2,800 at / before delivery)

**Deposit:** The deposit paid with a signed agreement on the Dog (puppy) shall be the only way to hold litter pick position and reserve a Dog (puppy) for purchase.

Buyer acknowledges and agrees that Buyer will forfeit the deposit and any rights to the Dog if:

- a) Buyer fails to complete the purchase of the Dog for any reason, or
- b) Buyer fails to pay the balance of the Purchase Price.

In either event, Seller shall be free to sell the Dog to another party.

**Litter Choice:** The Dog (Puppy) will be available for litter choice (based on order and type of deposits received) at (6) weeks.

**Pickup:** The dog (puppy) will be ready to go to her / his Furever Home starting Sunday August 28<sup>th</sup>, 2022. Special Arrangements can be made for delivery and delayed pickup (Individually quoted and agreed upon price). We prefer to have the puppies go home during the 8<sup>th</sup> week of life as this is the best socialization timeframe in their developmental growth.

In the event that the Dog (puppy) is not available due to sickness, death, or any other circumstance owing to the fault of Seller, Buyer's deposit will, at the Buyer's option, be either (i) refunded, or (ii) transferred to the next litter of puppies.

#### Transfer of Ownership and Registration

Upon payment in full of the Purchase Price, Seller (at Seller's sole cost) shall promptly take all actions required to officially transfer ownership and registration (if any) of the Dog to Buyer.





### **Seller's Representations and Warranties**

Seller represents and warrants to Buyer that:

- 1. Seller is the legal and true owner of the Dog and that Seller has full right and authority to sell the Dog.
- 2. The Dog is being sold free and clear of any lien, security interest, charge or other encumbrance.
- 3. Seller guarantees that the Dog is a purebred Dog, offspring of the purebred Sire and purebred Dam set out on page 1 of this Agreement.
- 4. The Dog is in good health and free of communicable diseases at the time of this sale. Buyer has (7) days from the delivery date to have the Dog examined by a licensed veterinarian, at Buyer's Sole cost. If the Dog fails the examination, Buyer may return the Dog, with a written statement from the veterinarian, for a full refund. Failure by Buyer to have the Dog examined within the (7) Day period will nullify this warranty. If Buyer chooses to keep the puppy, no replacement will be given and all medical costs and treatment are sole responsibility of the Buyer. This health Guarantee will be null and void.
- 5. This Guarantee does **NOT** cover Cherry eyes, Entropion, Ectropion, Allergies, undescended Testicles, loose knees or hips, Stenotic nares, elongated soft pallet, umbilical hernia, dermatitis, demodectic mange.
- 6. Seller will **NOT** replace a puppy due to heat stroke, abuse / neglect, or Improper socialization.
- 7. To ensure that Buyer does not euthanize the Dog or take it to an animal shelter, Seller will take The Dog back at any time during the Dog's lifetime. Seller will not issue a refund or provide another Dog to Buyer unless the Dog's return was a result of any misrepresentation on the part of Seller with respect to the Dog's health.
- 8. The seller will give a 2 YEAR hip and joint guarantee on the dog. The seller will also give a 1 YEAR general health guarantee (this does not include accidental death or any injury that the Dog may incur after the new owner has taken possession.

#### **Fitness of Purpose**

The Dog was bred as a companion animal, and Seller does not provide any warranty as to the Dog's fitness for any specific purpose, including obedience trials, show ring performance, and/or breeding purposes unless specifically stated and the full registration is purchased.

## **Buyer's Representations**

Buyer represents to Seller that:

- a) Buyer will provide the Dog with nutritious food and necessary veterinary care, includingDeworming, heartworm prevention and regular vaccinations (including rabies)
- b) Buyer will spay or neuter the Dog as soon as it is age appropriate (unless upgraded to Full AKC Registration).

#### **Indemnity and Release**

If any action or failure to act on the part of the buyer shall result in any claim, suit, loss, damage, injury, death, or liability, Buyer agrees to defend, indemnify, and hold seller harmless and to pay all of Seller's costs and expenses, including reasonable legal fees, any amount paid in settlement and any award or judgement with respect thereto. Buyer releases Seller from any and all liability, costs or damages causedby the Dog after placement with Seller, including but not limited to or destruction of property and injury to any person.

#### Limitation of Action

Any action or claim brought by Buyer against Seller for breach of this Agreement or for loss due to negligence must be brought within one (1) year of the date of such claim or loss occurs.
